**ORDER**

THIS MATTER having come before the court on Lead Plaintiff's Motion requesting the Court's (i) authorization to deposit the proceeds that have been paid to or for the benefit of the SemGroup Class on the Lehman Claim into the Settlement Fund for the above-captioned action (the "Litigation"); (ii) authorization to deposit any and all future proceeds paid to or for the benefit of the SemGroup Class from the Lehman Claim into the Settlement Fund; (iii) approval of payment of 19% of the proceeds that have been received on the Lehman Claim to date (i.e., \$50,787.00) as attorneys' fees to Lead Counsel; (iv) approval of payments of 19% of any future proceeds received on the Lehman Claim as attorneys' fees to Lead Counsel; (v) approval of reimbursement of expenses in the amount of \$41,909.07 to Lead Counsel; (vi) approval of reimbursement of any additional expenses to be incurred by Lead Counsel following this submission in an amount up to \$2,500.00; the Court having considered all papers filed and proceedings had herein and otherwise being fully informed in the premises and good cause appearing therefor; IT IS HEREBY ORDERED, ADJUDGED , AND DECREED that:

1. For purposes of this Order, the terms used herein shall have the same meaning as set forth in the Stipulation of Settlement dated May 3, 2011 (the "Stipulation") and Lead Plaintiff's Motion and supporting memorandum.


2. Pursuant to the Court's Final Judgment and Order of Dismissal with Prejudice entered in the Litigation on October 5, 2011, the Court has jurisdiction over the subject matter of this application and all matters related thereto.

3. The Court hereby authorizes Lead Counsel to (i) deposit the proceeds that have been paid to or for the benefit of the SemGroup Class on the Lehman Claim to date (i.e., \$267,300.00) into the Settlement Fund for the Litigation; and (ii) deposit any and all future proceeds paid to or for the benefit of the SemGroup Class from the Lehman Claim into the Settlement Fund.

4. The Court hereby awards Lead Counsel (i) attorneys' fees in the amount of 19% of the proceeds that have been received on the Lehman Claim to date (i.e., \$50,787.00); (ii) attorneys' fees in the amount of 19% of any future proceeds received on the Lehman Claim; (iii) expenses in the amount of \$41,909.07; and (iv) up to \$2,500.00 for any additional expenses incurred by Lead Counsel following this submission. The Court finds that the forgoing awards of attorneys' fees and expenses to be fair and reasonable.

5. There is no reason to delay in the entry of this Order and immediate entry by the Clerk of Court is expressly directed pursuant to Rule 54(b) of the Federal Rules of Civil Procedure.
